- The Discount **is only applicable to campus-based Degree programmes indicated in the above list.**
- Students must enrol for **the 1st full year of the Degree programme.**
- The Discount **cannot be combined with other promotions** or discounts offered by the University **for Tuition fees**, and only the one that benefits the student the most shall be applied.
- The Discount **can be combined** with other promotions or discounts offered by the University for Place Reservations.
- The actual application of the Discount shall be subject to approval from the administrative authorities of each Degree Programme, as well as to fulfilling the minimum number of students.
