

## Legal basis of the discount

### PROMOTION DEFINITION

A **limited number of discounts between 15% and 20%** (hereinafter, '**the Discount**') shall be granted on the amount charged for Tuition in the 1st year of the degree for first-time students who enrol for the **2025/2026 academic year** in the following degree programmes at Universidad Europea de Andalucía (hereinafter the 'Degree Programmes').

#### Degree programmes<sup>1</sup> to which the Discount applies:

- Master's Degree in Orthopaedic Manual Therapy in Pain Management
- Master's Degree in Sports Training and Nutrition
- Master's Degree in Eating Disorders and Obesity
- Master's Degree in Neurological Physiotherapy: Neuroscience and Rehabilitation
- Master's Degree in Marketing
- Master's Degree in Business Analytics
- Master's Degree in International Business
- Master's Degree in Digital Communication and Entrepreneurship
- Master's Degree in Big Data Analytics

### REQUIREMENTS

- The Discount **is only applicable to first-time students who enrol on the Degree Programme until 31 July 2025.**
- The Discount **is only applicable to campus-based Degree Programmes indicated in the above list.**
- Students must enrol for **the 1st full year of the Degree Programme.**
- The Discount **cannot be combined with other promotions** or discounts offered by the University **for Tuition fees**, and only the one that benefits the student the most shall be applied.
- The Discount **can be combined** with other promotions or discounts offered by the University for Place Reservations.
- The actual application of the Discount shall be subject to approval from the administrative authorities of each Degree Programme, as well as to fulfilling the minimum number of students.

### DATA PROTECTION

Furthermore, unless you declare otherwise by certifiable means, you expressly consent to the
