2. PRESENTATION

The subject of Psychological Assessment is compulsory and is taught in the second year of the bachelor's degree in psychology. Psychological assessment is the discipline that deals with the study of human behaviour, both individual and group, with different objectives, through the application of various measurement tools and techniques. Psychological assessment skills, as well as the various models, methods, techniques, and instruments used in the assessment process, are essential knowledge for psychology professionals, regardless of the professional field in which they work.

Psychological assessment is a process with predetermined phases that coincide with those of the scientific method. It is considered an essentially applied subject, involving evaluative judgements at different points in time, and therefore involves ethical issues that require deontological consideration. Furthermore, it must be related to previous knowledge of human behaviour and the characteristics of observation techniques (e.g., psychophysiology, personality and intelligence, psychopathology, and basic psychological processes, as well as statistics and psychometrics).

7.1. Ordinary call period

Campus-based mode:

To pass the course in the Ordinary call period you must obtain a grade greater than or equal to 5.0 out of 10.0 in each of the assessment systems of the course.

If cases of plagiarism are detected in any of the activities delivered, the grade will be **0** and this activity will be suspended during the Ordinary call period. Late delivery of activities is not allowed either (it will be evaluated with a "0"), except in duly justified cases. These activities must be recovered in Extraordinary call period, applying rules of the assessment period.

Finally, to pass the course in the Ordinary Exam period, a minimum of 50% of class attendance is required. Absence excuses do not imply the elimination of such absences in any case.

in the Ordinary Exam period the student will have a global grade of the course, thus consuming call for entries.

Virtual mode:

To pass the Subject in Ordinary call period you must obtain a grade greater than or equal to 5.0 out of 10.0 in the final grade (weighted average) of the course.

In any case, it will be necessary to obtain a grade greater than or equal to 5.0 in the final test, so that it can be averaged with the rest of the activities.

If cases of plagiarism are detected in any of the activities submitted, the grade will be **0** and this activity will be suspended during the Ordinary call period. Late delivery of activities is not allowed either (it will be evaluated with a "0"), except in duly justified cases. These activities must be recovered in Extraordinary call period, applying the same rules in that call for entries.

7.2. Extraordinary call period

Activities not passed in the Ordinary call period must be handed in, after having received the corresponding corrections from the teacher, or those that were not handed in.

The European University of Valencia establishes the continuous assessment as a system of evaluation of knowledge, Skills and basic, general, cross-disciplinary and specific Competencies of the qualification of "Bachelor's Degree in Psychology", in accordance with the provisions of the Regulations for the evaluation of Bachelor's Degrees. To pass the Subject in Extraordinary call period you must obtain a grade greater than or equal to 5.0 out of 10.0 in the final grade (weighted average) of the course.

In any case, it will be necessary to obtain a grade greater than or equal to 5.0 in the final test, so that it can be averaged with the rest of the activities.



Activities not passed in the Ordinary call period must be handed in, after having received the corresponding corrections from the teacher, or those that were not handed in.
