#### 2. INTRODUCTION

This is a core subject area taught in the second semester of the second year of the Bachelor's Degree in Physiotherapy. It is worth 6 ECTS credits and is a compulsory subject area within the degree.

Health Law and Management Skills introduces students to the basic rules that health professionals must know in order to practice their profession, and ensures the acquisition of management skills that will help them to correctly carry out tasks of physiotherapy besides those that are strictly clinical/care-based.

## 3. SKILLS AND LEARNING OUTCOMES

# 7.1. Ordinary exam period

To pass the subject area in the ordinary exam period (resits), students will need a final grade higher than or equal to 5.0 out of 10.0 (weighted average) for the subject area.

Follow-up and commitment to your studies are essential for assessing your learning and to ensure we provide you with quality teaching. Therefore, to pass the subject area in the ordinary exam period, you



must attend at least 50% of the on-campus sessions, as well as hand in all the activities and achieve a minimum grade of 5 out of 10, both in the objective tests and in the practical management work (you must pass both blocks in order to pass the subject area). Please note the language rules and plagiarism regulations in the annexes, which also apply.

You must achieve a mark of 5 or higher in each individual block in order to pass the subject area. Students who do not pass the Health Law or Management Skills block in the ordinary exam period must resit the block they have failed in the extraordinary exam period

## 7.2. Extraordinary exam period (resits)

To pass the subject area in the extraordinary exam period (resits) you must obtain a grade higher than or equal to 5.0 out of 10.0 as the final grade (weighted average) for the subject area.

To pass the subject area in the extraordinary exam period, you must hand in all the tasks that you did not hand in or pass during the ordinary exam period, taking into account the teacher's comments and insights. A minimum grade of 5 out of 10 in both blocks is required to pass the subject area. The health management project must be submitted and presented in the same way as in the ordinary exam period. All the requirements applicable to the ordinary exam period remain unchanged.
