2. INTRODUCTION

The subject of Administrative Law II completes the study of the function of public authorities under the current framework of state organisation. It expands on the content covered in Administrative Law I, giving it the material perspective required to understand the reasoning behind the special legal status afforded to public authorities in their attempt to serve the general interests of the community. A comprehensive view of this area of law is thus achieved.

Specifically, the subject deals with the different kinds of activity carried out by public authorities (control, promotion, public service, punitive action), the law governing the assets and personnel involved in the pursuit of public authorities' assigned objectives, and the potential liability of public authorities arising from damages suffered by individuals where they are not obliged to endure such damages.

This approach aims to help the student understand the reasoning behind current legal regulation, to become familiar with the terminology used in this area of law, and to learn to identify the function performed by public authorities in the course of the day-to-day activities that the student may face in their professional or private life.

- **CT9:** Problem solving: Ability to resolve an unclear or complex issue or situation which has no established solution and requires skill to reach a conclusion.
- **CT11:** Decision making: Ability to choose between different options or methods to effectively solve varied situations or problems.

Specific skills (CE, by their acronym in Spanish):

- **CE1:** Ability to navigate the framework of legislation, legal doctrine and case law governing public and private legal relations.
- CE2: Ability to understand the law as a systematic, coherent whole, taking into account issues
 within the socioeconomic context.
- **CE5:** Ability to make convincing legal arguments.
- **CE7:** Ability to develop critical awareness in the analysis of the legal system.

Learning outcomes (RA, by their acronym in Spanish):
