#### 2. INTRODUCTION

European Union Law is a core subject area delivered in the second year of the Bachelor's Degree in Law, worth 6 ECTS credits. The importance of this subject area within the syllabus is clear, given that Spain is part of a group of states comprising the European Union, whose rules the national courts are compelled to apply. Furthermore, certain commercial and administrative/economic matters are almost exclusively regulated by European legislation.

This is beneficial for individuals, who enjoy economic advantages and political rights deriving from membership of the Union.

In effect, the existence of a single market in which the free movement of persons, goods, services and capital is guaranteed has raised the standard of living of the European population. Furthermore, the recognition of certain rights for every citizen in the Union, such as to vote and stand as a candidate in local elections in their country of residence, as well as in elections to the European Parliament, has made it possible to ensure the Member States benefit from the enriching diversity resulting from having different nationalities in the same European country. In short, knowledge of EU regulations will provide students with the essential legal tools to leverage any decision regulated by EU law.

In order to have a complete overview of EU regulation, the contents covered include the history of the formation of the European Union and the specific matters affected with each development made to the primary law. It will also be necessary to identify the actors that make the existence of EU Law possible, particularly the following EU institutions: the Commission, Council, European Parliament and Court of Justice. A further distinguishing feature of the European Union to be studied is the legal rules and their effect upon implementation by the competent authorities in the different Member States. We will also consider the economic aspect of the EU and the existence of a single market, where goods and factors of production circulate freely, companies respect free competition and the Union's policies contribute towards achieving a true single economic area.
