2. INTRODUCTION

The subject area of Labour Law II is essential in any Law syllabus, as it deals with the regulation of a subject that affects the welfare of practically all Spanish 'citizens' (and 'residents' to a large extent): the benefits of so-called social security, in its broadest sense.

Furthermore, it deals with the study of collective labour disputes and, in connection with this, the autonomous settlement of collective labour disputes.

In terms of skill acquisition, this subject area represents an opportunity for students to expand on both their knowledge of labour law and the research skills needed to navigate legal scholarship and case law on the subject.

The subject area 'Labour Law II' is thus approached from a theoretical and practical point of view, placing the student in a favourable position when faced with real-life scenarios, as they will be able to solve them by applying the knowledge and skills acquired.

3. SKILLS AND LEARNING OUTCOMES

Basic skills (CB, by their acronym in Spanish):

- **CE5:** Ability to make convincing legal arguments.
- **CE7:** Ability to develop critical awareness in the analysis of the legal system.
- CE8: Ability to identify legal issues and provide appropriate solutions to real situations.

- RA1: Knowledge and understanding of the functioning of social security institutions and beneficiaries.
- RA2: Knowledge and understanding of the different types of labour disputes, including collective labour disputes and out-of-court settlements.
