2. INTRODUCTION

The importance of this subject area within the curriculum is clear, as we intend to educate future legal experts who, regardless of their area of professional practice, need to study the solutions put forward by the legislature with regard to family relationships and to property inheritance when someone dies.

Students will consider essential questions of family law and inheritance law, in two distinct sections of the subject area.

Specifically, in the area of family law, students will learn about the basic obligations arising from this legal institution and regime of marriage and de facto unions; highlighting not only the personal matters involved, but also those to do with property.

With regard to inheritance law, it will be important to underline the difference between intestacy and testacy. We will mainly consider different types of wills in cases of testacy. Likewise, we will study intestacy, where the deceased fails to leave a will.

We will not only study the law of the land, but also the specific areas of regional law that deal with family and inheritance law.

In addition to acquiring theoretical knowledge of family law and inheritance law, students will also develop the necessary skills to help them solve practical cases, in order to gain a real insight into the subject area.
