2. INTRODUCTION

This subject area aims to study the regulation of the main sectors of the market economy, which have become the main drivers of the economy and are considered to be public services due to their importance. For this reason, the Legislator has required the intervention or intermediation, where appropriate, of the government in order to supervise this interventionism.

- CT12 Teamwork: Ability to integrate and collaborate actively with other people, areas and/or organizations to reach common goals.
