# 2. INTRODUCTION

The optional subject area "University Activities" gives students the chance to complete certain activities of their choice, from a range of several different opportunities offered by the University itself or the Faculty every year.

Students may therefore choose to obtain ECTS credits through an optional subject area which involves taking part in initiatives for collaboration, volunteering, social action or community development, thereby ensuring a holistic approach to the study of the discipline. This subject area offers a range of opportunities for the student to combine the essential skills of the Degree through a cross-cutting approach to acquiring values, social responsibility and knowledge provided through learning activities such as seminars and lectures.

For the Bachelor's Degree in Law, the accumulable ECTS credits that can be recognised for the subject area are distributed as follows:

- 1 ECTS for the Student Mentoring Programme.
- 1 to 4 ECTS for the activities of each Faculty/School
- 1 to 4 ECTS for Campus Life activities (workshops, lectures or Cultural Passport)
- 1 to 4 ECTS for volunteering activities
- 1 to 4 ECTS for activities to promote sports
- 1 to 4 ECTS for Professional Careers activities
- 1 to 4 ECTS for participating in professional workshops and lectures at the University.

Therefore, the activities for which ECTS credits can be awarded are:

- Attend and participate actively in seminars, lectures and workshops. Depending on the activity, you may be asked to submit a final report, summary or reflective essay. Credits recognised: according to duration of the activity.
- Take part in careers workshops and lectures at the University. Credits recognised: according to duration of involvement.



- Active cooperation and participation in student clubs and associations. Submit schedule of activities and a report.
- Participate in the Council of Delegates (body of student representatives) Submit schedule of activities and a report. Credits recognised: 1 ECTS.
- Participation in Cultural Passport activities. Activities will only be recognised where carried out with organisations that have a valid signed collaboration agreement. Credits recognised: a minimum of 8 activities will gain 1 ECTS.
- Participation in volunteering at the national level. Credits recognised: 1 ECTS is worth at least 2 hours per week.
- Participation in a development aid project (international volunteering). Credits recognised: 3 ECTS.

Students must take into account that some of these activities require prior registration.

In all cases, to be awarded credits for participation in activities, students must:

- 1. Sign the attendance sheet (if the activity requires).
- 2. Complete the activity report (available on the Virtual Campus), to be signed by the person in charge of the activity once it has been completed.

Finally, all completed activity reports must be submitted to Student Services.

## 3. SKILLS AND LEARNING OUTCOMES

### Basic skills (CB, by their acronym in Spanish):

- CT5: Awareness of ethical values: Ability to think and act in line with universal principles based on the value of a person, contributing to their development and involving commitment to certain social values.
- CT6: Information management: Ability to seek, choose, analyse and integrate information from diverse sources
- CT7: Initiative and entrepreneurial spirit: Ability to undertake difficult or risky actions with resolve. Ability to anticipate problems, propose improvements and persevere to ensure they are implemented. Willingness to take on and carry out tasks.



- CT8: Critical reasoning: Ability to analyse an idea, occurrence or situation from different perspectives and adopt a personal viewpoint based on scientific rigour and objective reasoning, rather than intuition.
- CT9: Problem solving: Ability to resolve an unclear or complex issue or situation which has no established solution and requires skill to reach a conclusion.
- CT10: Innovation/Creativity: Ability to propose and invent new, original solutions that contribute towards improving problem situations, including ideas from other contexts.
- CT12: Teamwork: Ability to integrate one's self and collaborate actively with other people, departments and/or organisations in order to reach common goals.

### Specific skills (CE, by their acronym in Spanish):

- CE2: Ability to understand the law as a systematic, coherent whole, taking into account issues within the socioeconomic context.
- CE5: Ability to make convincing legal arguments.
- CE6: Ability to be diligent and responsible in the professional practice of a lawyer or other legal professional, staying up to date on legal matters.
- CE9: Ability to understand different legal systems in a globalised context.

#### Learning outcomes (RA, by their acronym in Spanish):

• RA1: Taking initiative, a sense of responsibility and collective awareness through participation in and/or organisation of activities that benefit the university community or society as a whole.
