2. PRESENTATION

The subject of Legislation, Professional Ethics, and Healthcare Management is taught in the second semester of the Nursing Degree's first year.

The main objective of this subject is to contribute to the professional awareness of future nursing professionals, manifested in socially responsible behavior regarding the specific duties of this profession. It also aims to differentiate and relate the concepts and particularities of ethics and legislation in nursing, the former referring to duty and the latter to law, as one cannot be understood without the other, since rules acquire meaning within a framework of moral values upheld by society.

Regarding healthcare management, it is worth noting that it has gained great importance in recent years, with the increase in management activities in healthcare, human and material resources, economic aspects, quality of life, etc. In short, it is advisable to delve into these aspects with the aim of providing students with the necessary skills to adequately perform one of the most relevant functions of nursing professionals: healthcare management.

3. COMPETENCIES AND LEARNING OUTCOMES

Basic Competencies:

Individualize care considering age, gender, cultural differences, ethnic group, beliefs, and values.
