2. PRESENTATION

The subject "International Conflict of Laws" is mandatory within the curriculum of the degree in International Relations. It is worth six ECTS credits, and is taught in the third year of the degree.

The importance of the subject in the curriculum is obvious, since the globalization that currently exists has led to an increase in legal relations connected with more than one legal system. In order to resolve disputes involving external legal transactions, the states that make up the international community have adopted specific legal systems for settling disputes between individuals involving a foreign element. These are problems that affect natural and/or legal persons when they come into contact with the laws of various states, which can occur due to the Spanish and foreign nationality of the subjects, their residences in different countries, the place of celebration of the legal act in question or its execution in another territory, among other cases. Specifically, the rules of international conflict of laws resolve disputes in the legal field of civil, commercial or labor law. Therefore, knowledge of these specific regulations will provide students with the essential tools to optimize any legal decision that affects individuals and is linked to several legal systems at the same time.

To achieve a complete overview of the rules governing international conflict of laws, the contents that the student will have to address involve becoming familiar with the object and content of this discipline, which will enable the identification of the main characteristics presented by international problems of a private nature regulated by this legal system. Whenever we are faced with a dispute involving individuals and connected with various legal systems, it will be necessary to answer three legal questions: which court will have jurisdiction to hear the dispute, what will be the law applicable to the substance of the matter and, finally, how a judicial decision issued in a country other than the one in which it is sought to be enforced can be recognized and enforced. All this is governed by procedural and substantive rules that have specific peculiarities, such as the indirect or conflict rule, which determines the substantive law that will be applicable to the substance of the matter by reference to another legal system. This is linked to the different matters covered by private law and which relate to personal, family and inheritance law, as well as to property law. A complete study of all international regulation is offered that solves the problems of international conflict of laws affecting individuals.



3. COMPETENCIES AND LEARNING OUTCOMES

- CC13: Problem solving. Ability to find a solution to a confusing issue or a complicated situation without a predefined solution that is hindering the attainment of an end.

- The evaluation concludes with a recognition of the level of learning achieved by the student and is expressed in numerical grades, in accordance with the provisions of current legislation.

Any assignments not passed at the first exam sitting must be resubmitted after having received the corresponding corrections by the professor, as well as any that were not submitted.
