2. PRESENTATION

3. COMPETENCIES AND LEARNING OUTCOMES

Core competencies:

- CB1 - Students have demonstrated knowledge and understanding of a subject area that builds on the foundation of general secondary education, and is usually at a level that, while supported by advanced textbooks, also includes some aspects that involve knowledge from the forefront of their field of study
- CB3 - That students have the ability to gather and interpret relevant data (usually within their area of study) to make judgments that include reflection on relevant issues of a social, scientific or ethical nature.
- CB5 - That students have developed those learning skills necessary to undertake further studies with a high degree of autonomy.

- CT16 - Decision making: Ability to make a choice between alternatives or existing ways to effectively solve different situations or problems.
- CT17 - Teamwork: Ability to actively integrate and collaborate with other people, areas and/or organizations to achieve common goals.
- CT18 - Use of information and communication technologies (ICT): Ability to effectively use information and communication technologies as a tool for searching, processing and storing information, as well as for the development of communication skills.

Specific competencies:

- CE11 - Ability to analyze, integrate and evaluate information from the socio-cultural environment, necessary for decision-making.
- CE13 - Ability to assess and apply principles of social responsibility in the company, paying particular attention to environmental management, oriented towards compliance with current legislation and as a source of opportunities, to reinforce the image and the production process in the company.
- CE14 - Effective communication and negotiation skills in the professional field of business administration.
- CE22 - Ability to evaluate ethical behaviors and decisions in business respecting human rights and the impact of productive activities on the environment both in the country of origin and in the different markets in which it operates.

7.1. First exam period

To pass the course in the first exam period, you must obtain a final course grade of at least 5 out of 10 (weighted average).

In any case, you will need to obtain a grade of at 4.0 in the final exam in order for it to count towards the final grade along with all the grades corresponding to the other activities.

7.2. Second exam period

To pass the course in the second exam period, you must obtain a final grade of at least 5 out of 10 (weighted average).

In any case, you will need to obtain a grade of at 4.0 in the final exam in order for it to count towards the final grade along with all the grades corresponding to the other activities.

The student must deliver the activities not successfully completed in the first exam period after having received the corresponding corrections from the professor, or those that were not delivered in the first place.
