# 2. PRESENTATION

The External Academic Internship is a compulsory subject within the approved curriculum for the training of graduates in Physical Activity and Sports Sciences at the European University.

This subject can be considered as a fundamental training area, since its purpose is to complement experimentally through real experiences, the theoretical knowledge acquired throughout the career.

In the conceptual descriptors of the subject included in the degree curriculum, the internships are described as: "Internships to be carried out by the student aimed at providing direct experience in any of the areas of physical activity and sport; as well as applied research techniques"

It is a subject that all future graduates of any Faculty of Physical Activity and Sports Sciences in Spain take. The European University offers you the possibility of choosing between different areas of development of the Practicum, as a response to the diversity of the demand for professionals in fields of action different from the traditional ones.

As you can see, external academic internships are the best opportunity for you to develop and apply all the knowledge you have acquired throughout your stay at the University, with the possibility of adapting it to the professional reality of the chosen field.

# 7. EVALUATION

The evaluation systems are listed below, as well as their weight on the total grade of the subject:

## **Face-to-face modality:**

Evaluation system	Weight
Report of the external tutor of internships	10-20%
Report of the academic tutor of internships	30-15%
Student's external academic practice report	35-60%
ECOE	10-15%

On the Virtual Campus, when you access the subject, you will be able to consult in detail the evaluation activities you must carry out, as well as the delivery dates and evaluation procedures for each of them.

# 7.1. Ordinary call

To pass the subject in the ordinary call, it is necessary that all the Items reach the minimum grade of 5 on a scale of 0 to 10, both the internship report, as well as the assessment of the external tutor, the assessment of the academic tutor, as well as the ECOE.

In the event of not exceeding the minimum grade of 5 in the report in the ordinary call for evaluation, you must pass the subject in the extraordinary evaluation by returning the failed document before the established date.



In the event that you do not exceed the grade of 5 in the assessment of the external tutor, you must repeat the subject in its entirety in the extraordinary official call, attending a new internship centre and repreparing your report and your reflective diary. In this case, it cannot be guaranteed that the internship can be carried out in an entity in the same field in which you developed the first experience.

In order to take the ECOE, it is essential to have completed the hours of stay at the internship centre. If you have not completed the internship process, you will not be able to apply for the ECOE.

If it is the case that a student passes the internship part at the centre and the report to be submitted, but does not pass the OSCE, he/she must repeat the OSCE in an extraordinary call In any case, it will be necessary for you to obtain a grade greater than or equal to 4.0 in the final test, so that it can average with the rest of the activities.

# 7.2. Extraordinary call

To pass the subject in the extraordinary call, you must obtain a grade greater than or equal to 5.0 out of 10.0 in the final grade (weighted average) of the subject.

If you have not passed the subject in the ordinary call, you must do so in the extraordinary call. If you have to complete the 150 hours of attendance at the internship center in the extraordinary evaluation call, you will not have the option of choosing the field of specialization, internship center or schedules and dates of completion. In this case, the assignment will be made according to the availability of the internship offer at that time, having to accept and respect the conditions proposed for this case. In other words, in no case can the internship be guaranteed to be carried out in the field chosen by the student or with the same regime as in the case of ordinary evaluation. To pass the subject in its extraordinary assessment call, it is necessary to have obtained the minimum grade of 5 on a scale of 0 to 10 in all items, assessment report of the external tutor and the academic tutor and the ECOE. If you do not exceed the minimum grade of 5 in the extraordinary evaluation call, you must enroll the subject again in the following academic year. In the event that you do not exceed the grade of 5 in the ECOE and have passed the rest of the parameters, you must enroll the subject again in the following academic year and complete it completely

In any case, it will be necessary for you to obtain a grade greater than or equal to 4.0 in the final test, so that it can average with the rest of the activities.

The activities not passed in the ordinary call must be submitted, after having received the corresponding corrections from the teacher, or those that were not delivered.

#### **COMMON FOR BOTH CALLS**

In the development of the subject, there are a series of rules that you are obliged to comply with and that in case of non-compliance on your part will cause you to lose the right to evaluation in the extraordinary call and therefore you will have to enroll in the subject the following year.

Please do not forget to consult these general rules of mandatory compliance and important considerations corresponding to this guide and be very scrupulous in their compliance. The internship report will be delivered on the platform for the Evaluation of Internships "UE Evalua". In pdf format, it may not exceed 20MB in size, and in no case will submissions of works outside this platform be accepted in any format other than the one requested or outside the established deadline. Works not delivered under these



conditions will have a grade of "0". If you submit a work that has been totally or partially plagiarized from another, you will automatically lose the right to the evaluation in its extraordinary call, having to enroll the subject again in the following academic year. In all cases, the evaluation concludes with a recognition of your level of learning and is expressed in numerical grades in accordance with the provisions of current legislation. If you do not reach the minimum score of 5 out of 10 in the grade of the extraordinary call, you will not have passed the subject and it will be necessary to re-enrol the whole process during the following year.
