### 2. PRESENTATION

The course on International Economic Law offers a critical and legal approach to the complex framework of rules and institutions that govern economic relations between states, international organizations, and private actors. Throughout the semester, students will explore the theoretical foundations of the international economic system, its historical evolution, and the emergence of key institutions such as the WTO and the IMF. The course examines international trade from its guiding principles to multilateral and bilateral regulation, as well as the global financial system, including monetary variables, international discipline, and capital regulation. It also addresses international business law, with a focus on the legal framework of business activity, investment protection (including the iLaw system), expropriation, and international regulatory frameworks. International contracting is studied from a comparative perspective, considering different types of contracts and legal conflicts arising from diverse legal systems. Finally, the course reflects on the challenges posed by the digital economy, particularly cybercrime, and the legal tools available to address it at the international level. This subject aims to prepare professionals capable of understanding and applying the law in a globalized, dynamic, and increasingly interconnected economic environment.

- 5) International contracting. Types of contracts (business and investment) and conflicts with different legal bases among countries.
- 6) The international economy. Cybercrime and the legal tools to combat it.
